The Contractor shall employ a sufficient number of workers skilled in their trade to perform the work. Unless otherwise specified, all materials shall be new and of good quality. 9. All work shall be completed in a workmanship-like manner and in compliance with all building codes and other applicable laws. 10. The Contractor agrees to re-execute any work which does not conform to the drawings and specifications. The Contractor also warrants all work performed, and agrees to remedy any defects resulting from faulty materials or workmanship for a period of _____ months after work completion. 11. Assignment for the above-described work shall be as follows (choose one):] Neither the Owner nor Contractor shall have the right to assign any rights or interest under this agreement between owner and contractor without the written consent of the other. The Contractor shall not assign any sums due, or to become due to him under the terms of this agreement. The Contractor may at his/her discretion engage subcontractors to perform the work hereunder, provided that the Contractor fully pays the said subcontractors and remains fully responsible for the proper completion of this work. 12. The Owner, Owner's representative(s) and public authorities shall have access to the work at all times. 13. The Owner agrees to maintain full insurance on the above-described work during the progress of the work, in his/her own name and that of the Contractor. The Contractor agrees to obtain adequate insurance for himself/herself against claims for property damages, bodily injuries and death due to the performance of this agreement. 14.
